

CLARK COUNTY R-1  
REGULAR MEETING—OPEN SESSION  
December 9, 2015

The Clark County R-1 Board of Education met in session on Wednesday, December 9, at 5:15 p.m. in the Board Room located at 427 W. Chestnut St. in Kahoka, Missouri. Brad Sprague, Board President, called the meeting to order at 5:15p.m.

Principals need to be in the buildings before and after school to talk with students and parents so this is not an ideal situation and we need to do something to get more drivers. Dr. Kracht shared a proposal, which may help with securing sub drivers.

Motion was made by Jason Acklie, seconded by Kevin Ross to accept the proposal from Dr. Kracht to increase the sub drivers per route to \$30, trip drivers to \$10 per hour and pay teachers/ coaches \$200 to get their bus license. Aye 6. Nay 0.
