

Clark County R-1 School Board  
Regular Meeting - Open Session  
December 13, 2018

The Clark County R-1 Board of Education met in regular session on December 13, 2018, at 6:00 pm in the boardroom located at 427 W. Chestnut St. in Kahoka, Missouri, Brad Sprague, Board President, called the meeting to order at 6:00 p.m.

Members present: Brad Sprague, President, Mark Plenge, Vice President, Jason Acklie, Kari Bevans, Craig Hunziker, and Kevin Ross, members. Charles West absent.

Dr. Kracht reported the Indian Pride Learning center is close to completion. The architects and engineers were here Wednesday conducting the punch list walk through. A few minor details still need to be completed inside the building. Staff should be able to start moving items into the building after Christmas break. The parking lot is close to being finished and if the weather holds out the driveway will be poured next week. The contractor must wait 21 days after pouring the concrete to add a protective sealant to the surface. Depending on weather conditions, we must wait another 7-14 days after the sealant is applied before vehicle traffic is allowed. We are hopeful to open the building to students in late January if the weather cooperates for the concrete work. The District will hold an open house for everyone in the community to walk through the new building once everything is complete and we can start using the parking lot.

Motion was made by Jason Acklie, seconded by Mark Plenge to accept the Rosetta Stone foreign language education contract of \$53,775 for 3 years (2019-2020 school year through 2021-2022 school year).

Dr. Kracht presented a list of other items which will need to be purchased for the Indian Pride Learning Center, these items include custodial equipment, shelving, classroom student tables, office chairs, etc..... The Board gave consent for Dr. Kracht to purchase these items. Dr. Rossmiller and the teachers are trying to utilize as much furniture and supplies we currently have in district to minimize costs. Dr. Kracht went through the financials for all the bond issue projects and the District is running within the allocated budget for all the projects.
