

CLARK COUNTY R-1
REGULAR MEETING—OPEN SESSION
August 5, 2020

The Clark County R-1 Board of Education met in regular session on August 5 at 6:00 p.m. in the High School Commons, located at 680 E. Main St. in Kahoka, Missouri. Mark Plenge, Board President, called the meeting to order at 6:00 p.m.

Board Member Heather Webster proposed to reduce class size numbers at Black Hawk to allow for more social distancing by having some students go to Running Fox for the year. After much discussion it was decided to allow this on a volunteer basis and parents will be responsible for their children's transportation both ways to Running Fox. The volunteer sign up will open up on August 13 and end August 17. The number of students allowed to transfer will be based on the number of current students enrolled at Running Fox and Black Hawk in each grade to try to balance the class sizes between the buildings. If more students request to transfer than slots are available at a grade level, there will then be a lottery for those who sign up for each grade that will determine who will transfer.

Motion made by Craig Hunziker, seconded by Heather Webster to allow students to volunteer to attend Running Fox for the 2020-2021 school year as numbers permit and as long as parents can transport them to and from school.

decision on whether to continue with our first 2 scheduled football games which are with schools who are located in the St. Louis metro area which is considered a hotspot for Covid activity.
