The Clark County R-1 Board of Education met in regular session on Monday, January 13, 2020, at 5:00 p.m. in the High School Library located at 680 East Main St. Kahoka, Missouri. Brad Sprague, Board President, called the meeting to order at 5:00 p.m.

Mr. Church reported that after much time and searching that he was able to lockdown Priory Academy out of Creve Couer, Missouri, for the 2020-2021 and 2021-2022 varsity football schedule. We will travel there in 2020-2021 season and play on the Saturday before Labor Day,

the following year they will travel here. The game at Priory Academy will be on Saturday afternoon due to Priory not having lights on their field.

Brad Sprague attended the meeting with the ball association and city about the purchase of new baseball fencing at an estimated cost of \$20,000. They asked Brad if he would report back to the school board and ask if the school district would be interested in helping out on the cost. Discussion was had amongst the board members and consent was that this was not the best way to use the district funds as this time.

Kevin Ross asked Dr. Kracht to give an update on how the chromebook release to the elementary buildings works. Dr. Kracht stated that the plan for the chromebooks that are currently being used for 1 to 1 in grades 7-12, are to be handed down to the elementary levels every year when replacements are bought for 7th grade and 10th grade. It was discovered last summer the current chromebooks we have were only going to be serviced by google until June 2022, which means that the devices themselves will not be supported by google, they can still be used but cannot be updated and they lose some of the management capabilities. There was confusion these chromebooks would be discarded and unable to use, but that is not the case. Black Hawk is in need of more chromebooks so that the grades 3-5 students can get more practice on the machines for upcoming testing practice, that is only done online. After much discussion the Board asked Mrs. Parrish to put a proposal together on what her current need is for chromebooks so that the needs can be met.
